

Mix the specified amount of CHB-BB2 in water to create a 1% solution and apply with sufficient volume for uniform and thorough coverage of foliage and/or fruit. Due to reduced coverage with carrier rates of 10 gallons per acre or less, aerial application requires a minimum dose of 12.8 oz./acre (see footnote ⁽¹⁾ below).
